One of the docs has change tracking (vs. yesterday's "clean" version), the other does not.

I wrote everything in Lisa's name, copied from the furnace letter. Don't know if that's correct, let us know.

I inserted several sections tooting SoCalGas' horn (merged from the furnace letter), and a large section about marginal electricity cost (Q5). That's been a pet peeve of mine for a long time and it beats me why PG&E never wants to address it. From hallway conversations with Marshall, because "they'll never do anything about it", but is that reason enough?? It's a big deal IMHO.

I got rid of some more of PG&E's verbiage, but also retained some that was just plain good IMHO. If you need a diff of this document vs. PG&E's latest original let me know. About 50% of the letter is pure "us" at this point, and the rest has been modified to various degrees. Similarities to PG&E's letter are still recognizable.
