## What is CAEECC?

The California Energy Efficiency Coordinating Committee ([CAEECC](#)) is a CPUC-authorized informal collaborative stakeholder process. CAEECC is made up of representatives from environmental advocacy groups, labor representatives, consumer advocates, energy efficiency implementers, local governments and state staff, and program administrators.

## What is the Evolving CAEECC Working Group (WG)?

The Evolving CAEECC WG is charged to examine and recommend an alignment of both a) the CAEECC Purpose, Objectives, Structure, and Processes to California's state and Public Utilities Commission (CPUC) goals of justice, equity, diversity, and inclusion and b) CAEECC to the evolving needs of the energy efficiency regulatory space. ## What will the Evolving CAEECC WG do?

The Evolving CAEECC WG will:

1. **Evaluate** the current CAEECC Purpose, Objectives, Structure, and Processes and identify recommended updates to these elements.
2. To the extent appropriate, **develop** a new proposed structure and submit recommendations for approval by CAEECC.
3. Review and **propose** any updates to the current governance documents and submit recommendations for approval by CAEECC.

The origin of these objectives stem from a preceding WG that were proposed and discussed at the April and June 2022 CAEECC Meetings.

## Why should I [apply](#) to the Evolving CAEECC WG?

CAEECC is at a pivotal moment where it is examining its purpose and inclusionary practices. This is an opportunity to play a critical role to help guide and define what CAEECC is and how it can lead California's energy efficiency programs towards a just future.

## What's the commitment for the Evolving CAEECC WG?

The Evolving CAEECC WG will meet virtually via Zoom and is anticipated to convene every 4-5 weeks for 2-4 hours each from June 2023 - January 2024. The exact dates and time frame are TBD and will be informed by applicant availability. Members should also expect some pre- and post-meeting work in addition to meeting attendance. ## Is there funding available for participation?

Yes! For this Working Group, CAEECC is piloting a compensation program, recently authorized by the CPUC. Compensation will be at the rate of \$150/hour. Accepted Pilot recipients will provide an attestation of both their financial need and participation in meeting time, and pre-/post-meeting work, which the facilitation team will verify before reimbursement.
