In accordance with Rule 1.12(c) of the Rules of Practice and Procedure of the California Public Utilities Commission (“Commission”), San Diego Community Power, on behalf of the San Diego Regional Energy Network (“SDREN”) provides this Notice of Errata regarding the *Application of San Diego Community Power for Approval of the San Diego Regional Energy Network (CPUC ID U-4001-E) 2028-2031 Portfolio Plan and 2028-2035 Business Plan* (“Application”),¹ Exhibit SDREN-01: 2028-2031 Portfolio Plan and 2028-2035 Business Plan Testimony.

On March 16, 2026, SDREN submitted its Application, as well as a Notice of Availability of several accompanying exhibits.² After submission, SDREN became aware of a minor typographical error in Exhibit SDREN-01, Table 2.5. Specifically, Table 2.5 is titled “4-Year Budget Forecast Summary (2028-2031),” but the values reflected in that table are associated with
