Antitrust Statement

Pursuant to the California Public Utilities Commission (CPUC) Decisions D.16-08-019 and D.18-05-041, SCE is hosting a meeting for the purpose of complying with the Energy Division's process checklist for closing a program in compliance with D.21-05-031 and is intended to take place in full compliance with all applicable provisions of the CPUC orders, rules and regulations and all applicable provisions of state and federal antitrust laws. These discussions will be conducted in full conformance with the Antitrust Guidelines. Among other things, the antitrust laws forbid any agreement between or among competitors regarding prices, availability of service, terms of sale, division or markets, allocation of customers or any other activity that unreasonably restrains competition, including components of pricing such as vendor or contractor costs. It is the responsibility of every participant at this meeting to carry out this commitment.

Background

- Decision 18-01-004 mandated IOUs transition at least 60% of portfolios to Third-Party Implementers who can design and implement new innovative programs.
- SCE conducted solicitations in 2019 to procure new Third-Party implementers.
- Multiple bids were received and reviewed. SCE executed multiple Third-Party contracts via the solicitations, which was monitored by Independent Evaluators and the PRG. Contracts were subsequently approved by the CPUC.
- A contract for the non-residential Third-Party led California Statewide energy efficiency Lighting Program (Midstream) was executed with TRC Solutions, Inc.

Program Closure Information

- The Program was launched into the market Q1 2021 and began submitting projects September 2021.
- The Program's Initial Delivery Date (October 1, 2021) was met.
- Effective as of June 29, 2023, D.23-06-055 provided CPUC approval for this program closure
- The parties mutually agreed to terminate the Contract, effective June 30, 2023.
- Service List and Stakeholders were notified July 17, 2023.

Steps for Closing This Program

1. Communicate with Program Implementer
2. Receive CPUC Approval for Closure
3. Notify Service List
4. Host Webinar
5. Update Program Status to "Closed" on CEDARS
